Dear MSYSA Board of Directors:

At its August Board Meeting, US Soccer plans to formally ratify a change in classification of age groups from school year (August 1 to July 31) to birth year (January 1 to December 31). The anticipated change *recommends, as a best practice, Member Organizations (including State Associations) adopt the change by August 2016. The mandate will occur in August 2017.*

With respect to Small-Sided Games, which our State Association is ahead on, *recommends, as a best practice, Member Organizations (including State Associations) adopt the following formats* by August 2016. The mandate will occur in August 2017.*

*U6 – U8 is 4v4 (with no GK)
U9 – U10 is 7v7 (with GK)
U11 – U12 is 9v9 (with GK)
U13 & up is 11v11 (with GK)
