They will serve the suspensions during the first matches of the spring season for the U13B TNT West 06b White team. ALL WERE IN FAVOR.

Game 1957-40 referee abuse complaint - AYSO United was present to discuss the issue. After discussion a motion was made to suspend Tim Guikema for all of 2019. ALL WERE IN FAVOR.

Game 1970-14 Alliance Forfeit protest - Alliance coaches were present to discuss the issue of them having four coaches on the bench during a match. After discussing the issue the decision was made for the forfeit to stand.

Game 1945-20 and 1945-23 SCOR forfeits - SCOR played with an illegal player in 2 games. They did not find out the issue until after the 2nd game was played. SCOR was present to discuss the situation. After discussion the decision was made to have the coach serve the 3 game suspension and pay the fine for game 1945-20 but no penalty for game 1945-23. There will be no consequences for the players involved.

Game 1969-19 late referees - the score will stand as recorded.

Game 1951-33 and 1952-20 Weather cancellation issues - Both games were weather cancellation issues. Rapids showed up to discuss their game issue with Revolution. Revolution was not present. Neither Fire nor Lakeshore Premier showed up to discuss their issue. The board discussed both games and tabled the decision until December.
